- (2) That in consideration of permitting the undersigned owner/operator to participate in this event, the owner/operator does hereby agree to indemnify and hold harmless the Westbrook First Congregational Church, all its officers, directors, employees, agents, member or assigns for any act of god or other acts or omissions which may result in theft, damage, destruction or injury to person or property occurring during or as a consequence of this event wherever located.
- (3) That owner/operator, in attending or participating in this event, does so voluntarily and assumes the risk of any and all damage to his/her vehicle and/or of injury to his/her self or others and holds Westbrook First Congregational Church harmless there from.
